### REQUEST FOR REFUND

Petitioner Supercell Oy (“Petitioner”) respectfully requests a refund of the post-institution fees paid by Petitioner in the instant proceeding.

On August 7, 2018, Supercell Oy (“Supercell”) filed a Petition for Post-Grant Review of U.S. Patent No. 9,808,723 (Paper 1) requesting review of nineteen claims. Petitioner paid a fee of \$41,300, including (i) \$16,000 for a post-grant review request fee for up to twenty (20) claims, (ii) \$22,000 for a post-grant review post-institution fee for up to fifteen (15) claims, and (iii) \$3,300 for a post-grant review post-institution fee of each claim in excess of fifteen claims (\$825 for four additional claims in excess of 15). On February 26, 2019, the Patent Trial and Appeal Board (“the Board”) issued a decision (Paper No. 9) denying institution of post-grant review on all challenged claims.

In accordance with 37 C.F.R. § 42.15(b)(2), Petitioner respectfully requests a refund of Petitioner’s paid post-institution fees, in the amount of \$25,300 credited to Petitioner’s USPTO Deposit Account (No. 19-2555).
