**PETITIONER SUPERCCELL OY'S REQUEST FOR REFUND  
OF POST GRANT REVIEW POST-INSTITUTION FEES  
PURSUANT TO 37 C.F.R. § 42.15(b)**

Petitioner Supercell Oy ("Petitioner") respectfully requests a refund of the post-institution fees paid by Petitioner in the instant proceeding.

On March 4, 2020, Supercell Oy ("Supercell") filed a Petition for Post Grant Review of U.S. Patent No. 10,307,676 requesting review of twenty-four claims.

[Paper 2] Petitioner paid a fee of \$46,925, including: (i) \$16,000 for a post grant review request fee for up to twenty (20) claims; (ii) \$22,000 for a post grant review post-institution fee for up to twenty (20) claims; (iii) \$1,500 for a post grant review of each claim in excess of twenty claims (\$375 for four additional claims in excess of 20); and (iv) \$7,425 for post grant review post-institution request for each claim in excess of twenty claims (\$825 for nine additional claims in excess of 20).<sup>1</sup>

On September 14, 2020, the Patent Trial and Appeal Board ("the Board") issued a decision denying institution of post-grant review on all challenged claims.

[Paper 14] On October 14, 2020, Petitioner filed a Request for Rehearing. [Paper 16]

On November 18, 2020, the Board issued a decision denying Petitioner's Request for Rehearing. [Paper 17]
