Petitioner's Request for Refund

Petitioner Supercell Oy ("Petitioner") respectfully requests a refund of the post-institution fees paid by Petitioner in the instant proceeding.

On May 8, 2020, Supercell Oy ("Supercell") filed a Petition for Post Grant Review of U.S. Patent No. 10,406,432 requesting review of nine claims. [Paper 2] Petitioner paid a fee of \$38,000, including: (i) \$16,000 for a post grant review request fee for up to twenty (20) claims, and (ii) \$22,000 for a post grant review post-institution fee for up to twenty (20) claims

On November 12, 2020, the Patent Trial and Appeal Board ("the Board") issued a decision denying institution of post-grant review on all challenged claims. [Paper 10] On December 14, 2020, Petitioner filed a Request for Rehearing. [Paper 11] On August 18, 2021, Petitioner filed an Unopposed Motion to Withdraw Request for Rehearing. [Paper 12] On August 19, 2021, the Board issued a decision and Granted Petitioner's Unopposed Motion to Withdraw Request for Rehearing. [Paper 13]

In accordance with 37 C.F.R. § 42.15(b)(2), Petitioner respectfully requests a refund of Petitioner's paid post-institution fees in the amount of \$22,000 credited to Petitioner's USPTO Deposit Account (No. 19-2555).
