**PETITIONER REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232–4234 (Jan. 18, 2013), Petitioner, Apple Inc., requests a refund in the amount of \$22,000 to be credited to Deposit Account Number 06-1050.

On June 11, 2020, Petitioner filed a Petition for Post Grant Review of U.S. Patent No. 10,455,066 with the Patent Trial and Appeal Board that was assigned case number PGR2020-00066.
