On August 12, 2020, Hunting Titan, Inc. (“Petitioner”) filed a Petition for Post Grant Review of U.S. Patent No. 10,472,938 seeking review of claims 1-20 of the patent. On February 12, 2021 the PTAB issued an Order denying institution.
