#### JOINT MOTION TO AMEND DOCKET CONTROL ORDER

Plaintiff GREE, Inc. ("GREE") and Defendant Supercell Oy ("Supercell") respectfully submit this Joint Motion to Amend the Docket Control Order in the above-referenced case.
