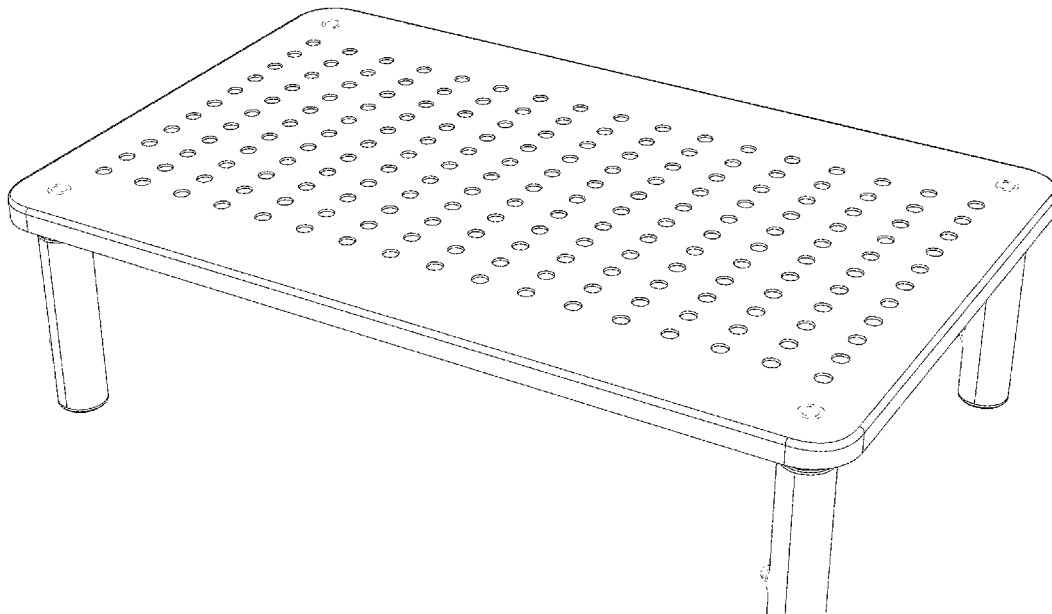
(57) **CLAIM**

#### DESCRIPTION

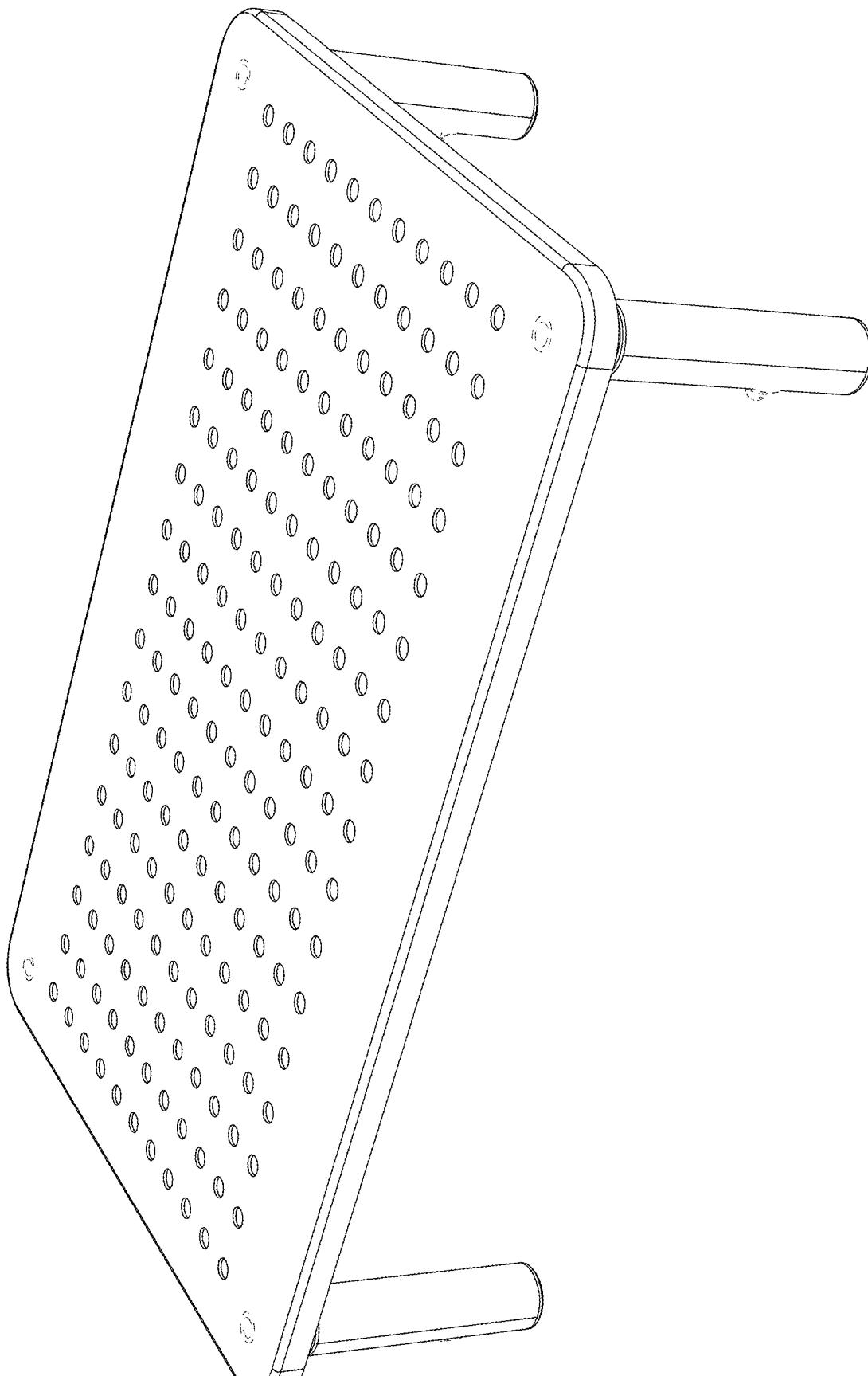

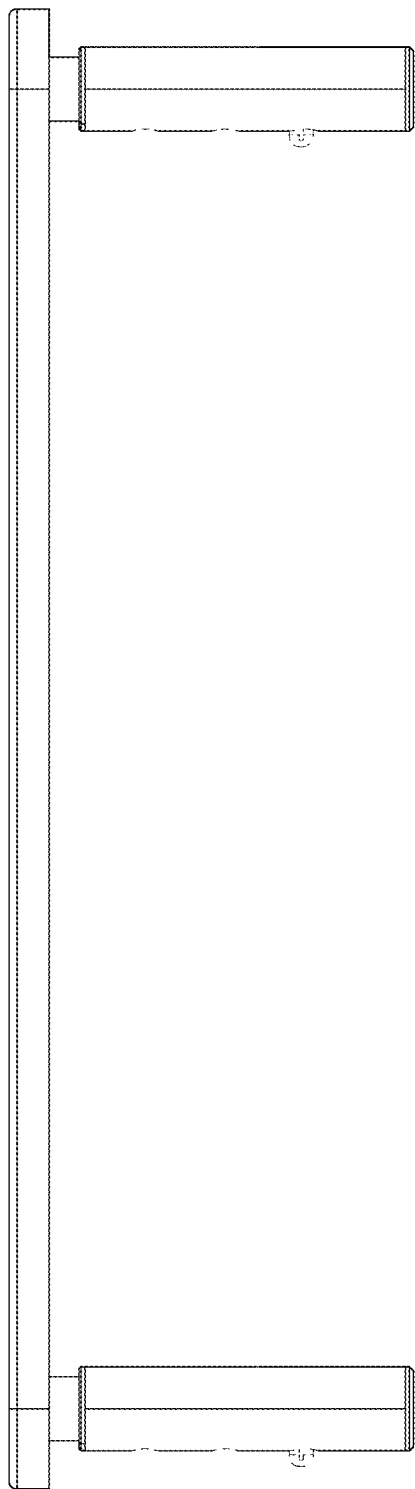

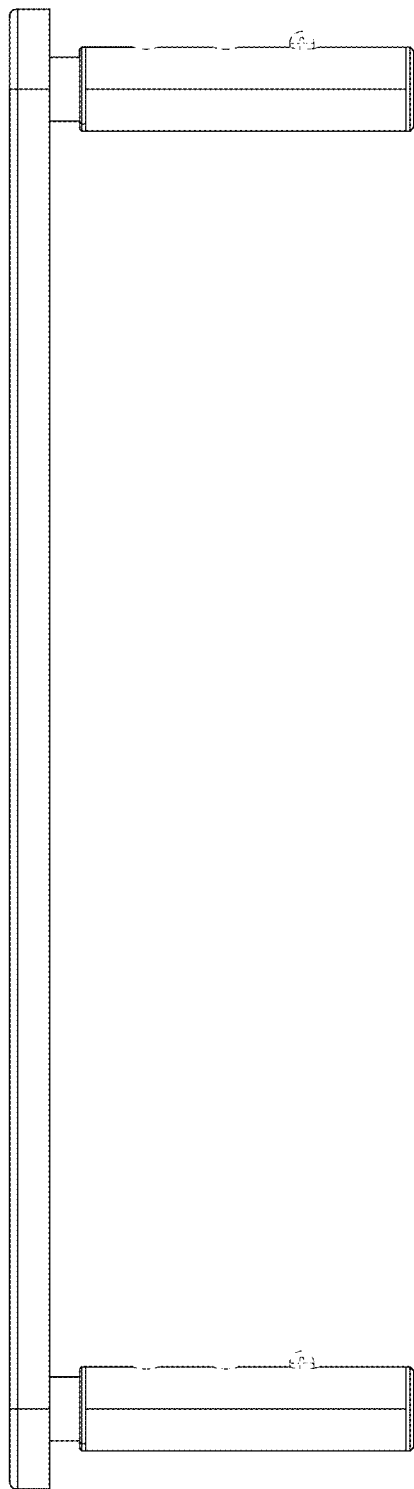

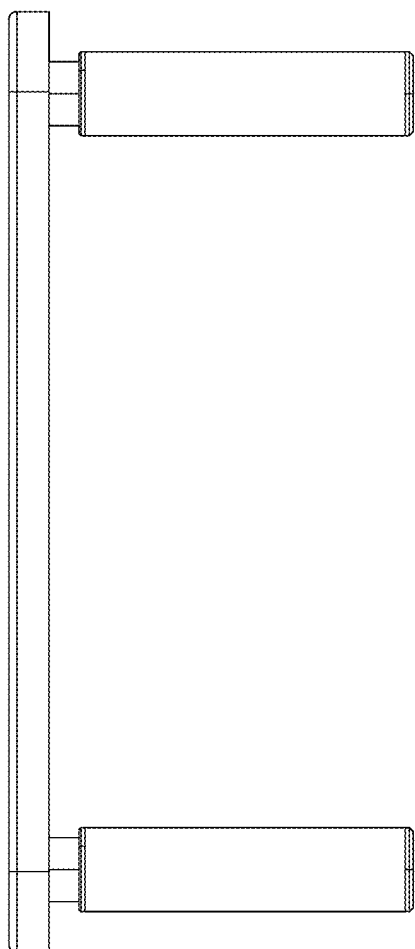
