DEMAND FOR JURY TRIAL

Plaintiff CLIF BAR INC, alleges as follows:

NATURE OF ACTION

- This action seeks preliminary and permanent injunctive relief against the following acts of Defendant: willful infringement of Plaintiff's trade marks and unfair competition, in violation of the Lanham Trademark Act of 1946, as amended, Title 15, United States Code, §§1051 et seq. (the "Lanham Act"); and dilution, injury to business reputation, false advertising, and unfair competition under California state law.
- Plaintiff CLIF BAR INC. is a California corporation whose place of business is 1610 2. Fifth Street, Berkeley, California, 94710.
 - Plaintiff is the lawful owner of the trademark MOJO BAR, which is the subject of



 Federal Registration No. 2,687,196, issued February 11, 2003, filed December 12, 2000, and Federal Registration No. 2,697,701, issued March 18, 2003 (the "MOJO BAR Mark") filed May 17, 2002, covering "ready to eat high energy nutrition bars for meal replacement" and "grain based ready to eat energy food bars." These registrations are in force and incontestable. By virtue of the filing date for its earlier registration, the MOJO BAR Mark has a priority date of December 12, 2000. The MOJO BAR Mark has been in use since at least April 2002. Plaintiff also owns the domain name www.mojobar.com, which was registered in 2002. That address points to www.clifmojo.com, also owned by Plaintiff. Plaintiff operates a website at that Internet address. Plaintiff also uses the mark MOJO to refer to its products and Plaintiff's customers know Plaintiff's product by the shorthand MOJO.

- 4. Upon information and belief, Defendant MOJO NUTS, INC., is a Colorado Limited Liability Company with an address at 517 Big Thompson Avenue P.O. Box 864, Estes Park, Colorado 80517. Defendant is in the business of manufacturing snack foods made from processed and unprocessed nuts and processed edible seeds. Defendant also owns the domain name www.mojonuts.com, which was registered in 2003. Defendant operates a website at that Internet address. Defendant's MOJO NUTS-branded products are offered and delivered to customers via the Internet and through other means.
- 5. Long after Plaintiff commenced use of the MOJO BAR Mark and filed its applications which resulted in the incontestable registrations noted above, Defendant adopted and began using the confusingly similar mark MOJO NUTS (the "Imitation Mark"), and registered and began use of the Internet domain name www.mojonuts.com (the "Domain Name"). Defendant uses the Imitation Mark and the Domain Name in connection with snack food products which are very closely related to the products with which Plaintiff uses its MOJO BAR Mark.
- 6. Unless Defendant is enjoined from continuing to use the Imitation Mark and the Domain Name to promote Defendant's products, the MOJO BAR Mark will continue to be infringed and will become further diluted, resulting in irreparable injury to Plaintiff, confusion of consumers, and harm to the public, thereby destroying the distinctive quality of the mark that Plaintiff has spent considerable time and resources developing and promoting.
