OPPOSER'S MOTION FOR SUMMARY JUDGMENT

Opposer, PHCP Inc., hereby moves the Board for an order, pursuant to Rule 2.127(d) of the Trademark Rules of Practice and Rule 56(a) of the Federal Rules of Civil Procedure, granting summary judgment in its favor on the ground that no genuine issue as to any material fact exists and that the mark at issue is confusingly similar as a matter of law.

This motion is based upon the application file, Opposer's U.S. Registration No. 3,278,053 and related holdings, the pleadings, Applicant's answers to written discovery (attached hereto as Exhibit A), Opposer's verified answers to Applicant's First Set of Interrogatories (attached hereto as Exhibit B), and the arguments presented herein.

In the event that a decision on the instant motion does not dispose of the proceedings, Opposer requests additional time for follow-up discovery.

I. <u>SUMMARY OF FACTS</u>

On July 20, 2005, Applicant, LG International Inc., filed Application Serial No. 76/643,242 for the mark GALGROOM in connection with "Lipstick, lip liner pencils, mascara, nail polish, eye shadow, eyeliner pencils, eyebrow pencils, foundation makeup, face powders, and rouges, soaps, perfume, hair shampoo, hair conditioner, hair spray, face and skin lotion, toothpaste, and mouthwash," in International Class 3 and "Retail store services including electronic catalog services, catalog ordering services, mail order catalog services and online retail store services in the fields of personal health, beauty and grooming products and cosmetics, and clothing and related accessories," in International Class 35. The intent-to-use based application also included goods and services in Classes 25, 44 and 45 which are not the subject of this proceeding. The application was published for opposition on September 5, 2006. Subsequent to obtaining an extension of time to oppose through January 3, 2007, the Notice of Opposition was filed on January 3, 2007.

The opposition is based upon Opposer's common law rights in the marks MENSGROOM and MENSGROOM & Design and the following pending, approved and registered US records:
