In many cases, the surname is derived from any of several like-named placenames in England, such as those in Devon, Kent, Lancashire (*Mearley*), Sussex (*Marley Farm*) and West Yorkshire.^{[1][2]} The placenames in Devon, Kent, and West Yorkshire are, in part, derived from the Old English element *leah*, meaning "woodland clearing".^[2] Early forms of the surname are *de Merlai*, in about 1145-1165; *de Mardele*, in 1208; *de Marley*, in 1285; and *de Marleye*, in 1306.^[1] In the 17th century, the surname was taken to Ireland by a family from Northumbria.^[2] However, in some cases the surname in Ireland may be an Anglicised form of the Irish-language *Ó Mearthaile*^[3] (another suggestion is *Ó Mearlaigh*; it is unlikely to be an Anglicised form of *Ó Murghaile*).^[4] Notable people with the surname include:
