NOTICE OF OPPOSITION TO REGISTRATION

- 1. The Application of Mesero Restaurant Group, LLC ("Applicant"), Serial Number 87385164 (the "Applicaton"), for the registration of "MESERO" (the "Mark") in connection with restaurant services should be refused registration because (i) Applicant does not have exclusive ownership of the Mark in connection with restaurant services, as Michael "Mico" Rodriguez ("Opposer") claims such ownership, and (2) the Mark is confusingly similar to the trademark used by Opposer since November 11, 2011.
- 2. As stated in the Affidavit of Opposer, attached hereto as Exhibit "A", Opposer has continuously used "Mesero" in connection with his restaurant business since November 11, 2011, and, therefore, prior use by Opposer.

- 6. Based upon the foregoing, Opposer asks that the United States Patent and Trademark Office refuse registration of the Mark under the Application.


