**NOTICE OF OPPOSITION**

---

Opposer Joey Tomato’s (Canada) Inc. (“Opposer”) will be damaged by registration of the mark shown in Application Serial No. 88392225 and therefore opposes the same, alleging as follows:

1. Opposer is a Canadian corporation having offices at 1177 West Hastings Street Suite 2400 Vancouver, BC Canada V6E 2K3.
2. Opposer is a well-known provider of restaurant, bar, and cocktail lounge services and other restaurant related services.
3. Since at least 2009, Opposer has used the mark LOCAL PUBLIC EATERY in connection with the above-mentioned services.
4. Opposer owns the following valid and subsisting U.S. trademark registration on the Principal Register:

A true and correct copy of this Registration is attached hereto as Exhibit A.

5. In addition to the federal trademark registration listed above, Opposer also owns common law rights for its LOCAL PUBLIC EATERY mark based on use in commerce in connection with the services listed above.

6. Opposer’s common law and federal registration rights in the mark listed in the preceding paragraphs are collectively referred to herein as the “LOCAL Mark.”

7. Opposer’s LOCAL Mark has achieved strength and wide public recognition as a result of extensive and continuous use by Opposer since before the filing of Application Serial No. 88392225 and before any use by Applicant of the mark identified in Applicant’s Application.

8. As a result of substantial sales and extensive advertising and promotion, Opposer has established valuable goodwill in the LOCAL Mark. The public has come to associate the LOCAL Mark with Opposer and to know the LOCAL Mark as an indicator of source. The LOCAL Mark is well known to purchasers.

**Likelihood of Confusion – 15 U.S.C. § 1052(d)**

9. Applicant The Local, LLC d/b/a The Local Limited Liability Company (“Applicant”) filed Application Serial No. 88392225 on April 18, 2019 for the mark THE LOCAL for use in connection with “Restaurant and catering services” in Class 43. The application was filed use-based, claiming a first use date of February 5, 2014 (“Applicant’s Mark”).

10. Applicant's Mark is similar to Opposer's LOCAL Mark in appearance, sound, connotation, and commercial impression.

11. The services identified in Application Serial No. 88392225 are identical to the services offered by Opposer under the LOCAL Mark and listed in the relevant registration.

12. The target customers and channels of trade for goods and services offered under the LOCAL Mark and Applicant's Mark are in some cases identical and in other cases are related and overlap.

13. Consumers expect Opposer's services and Applicant's services to emanate from the same source.

14. Based on the foregoing, a likelihood of confusion exists such that Applicant's services offered under Applicant's Mark may be thought by consumers to emanate from Opposer and may be confused with Opposer's services.

15. Registration and use of Applicant's Mark is likely to cause confusion, mistake, or deception as to the source or origin of Applicant's services, or to induce purchasers to believe that Applicant's services are those of Opposer, or are endorsed by, affiliated with, or associated with Opposer.

16. If Applicant's Mark is permitted to register, the registration would presumptively entitle Applicant to *prima facie* exclusive ownership and rights to the mark and would, therefore, cause confusion among consumers of the relevant services as to source and as to the relationship of Opposer and Applicant, thereby damaging Opposer and its LOCAL Mark and irreparably injuring Opposer's business, goodwill, and reputation.

**In the alternative - Merely Descriptive – 15 U.S.C. § 1052(e)**

17. Opposer repeats and realleges each and every allegation set forth in the preceding paragraphs as if set forth fully herein.

18. Applicant's Mark is used for restaurant and restaurant-related services, as identified in Paragraph 9.

19. The term LOCAL, by itself, is a descriptive term widely understood by the relevant consuming public to refer to a "neighborhood pub." *See* Exhibit B.

20. The term LOCAL, by itself, is also a descriptive term widely understood by the relevant consuming public as relating to a particular place. *Id.*

21. Applicant's Mark merely describes a feature, characteristic, and/or quality of Applicant's services, including that its restaurant and restaurant related services are offered in a particular place or neighborhood, and/or that its restaurant is a "neighborhood pub," and is therefore, descriptive.

22. Applicant did not make an acquired distinctiveness claim or submit any evidence of acquired distinctiveness.

23. The U.S. PTO commonly requires the term LOCAL to be disclaimed when used in connection with restaurant-related goods and services. *See* Exhibit C.

Wherefore, Opposer requests that this Opposition be sustained and that registration of Applicant's Mark in the Application Serial No. 88392225 be denied. The filing fee of \$400 per class is enclosed as required by 37 CFR §§ 2.101 and 2.6(a)(17). The Commissioner is also authorized to charge any additional fees that may be required, or credit any overpayment, to this firm's Deposit Account No. 195117.

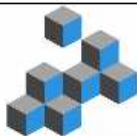

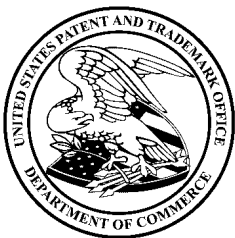
