NOTICE OF OPPOSITION

Opposer Space Exploration Technologies Corp. ("SpaceX" or "Opposer") believes that it will be damaged by the registration of the mark "SPACE X" (the "Gursatya Mark") as set forth in Application Serial Number 90/513,062 (the "Gursatya Application"), by Gursatya Wholesale LLC ("Applicant").

As grounds for this opposition it is alleged that:

In the Matter of Application No. 90/513,062

- 1. Opposer is a pioneering private aerospace company and provider of space launch services. For over 15 years, SpaceX has used its famous trademark SPACEX in connection with designing, manufacturing, and launching advanced rockets and spacecraft ("Opposer's Goods and Services"). Additionally, SpaceX provides satellite internet services via its groundbreaking STARLINK program.
- 2. As a result of Opposer's success, innovation, and achievements, the SPACEX mark has come to embody the substantial and valuable reputation and goodwill that SpaceX has garnered in the marketplace. Indeed, the mark is readily recognized among the general consuming public.

Opposer's SPACEX mark has been covered extensively by prominent publications such as The New York Times, The Washington Post, The Chicago Tribune, The Los Angeles Times, USA Today, Fortune, and TIME.
