7. Petitioner's use of its YOU DESERVE RESPECT AND JUSTICE SO WE DEMAND IT! mark has been valid and continuous since at least as early as August 29, 1996.

18. Respondent knew about Petitioner and its prior use of its mark YOU DESERVE RESPECT AND JUSTICE SO WE DEMAND IT!, and with such knowledge filed an application to register its YOU DESERVE RESPECT & JUSTICE SO I FIGHT FOR IT mark.

19. Respondent has a website, www.elpasotexasinjurylawyer.com, which shows use of Respondent's YOU DESERVE RESPECT & JUSTICE SO I FIGHT FOR IT mark for legal services.

20. Petitioner has a website, www.waynewright.com, which shows use of Petitioner's YOU DESERVE RESPECT AND JUSTICE SO WE DEMAND IT! mark for legal services. Petitioner filed a trademark application for the YOU DESERVE RESPECT AND JUSTICE SO WE DEMAND IT! mark on August 29, 2012 and was given Application number 85/716,080 in International Class 45 for legal services.
