**JOINT MOTION TO WITHDRAW DEFENDANTS' OPPOSED MOTION TO
AMEND THE DOCKET CONTROL ORDER [DKT. NO. 244]**

Plaintiffs Uniloc USA, Inc. and Uniloc Luxembourg S.A. (collectively “Uniloc”) and Defendants ADP, LLC (“ADP”) and Big Fish Games, Inc. (“Big Fish”) (collectively, “Defendants”) hereby respectfully move to withdraw Defendants’ Opposed Motion to Amend the Docket Control Order (Dkt. No. 244, “Defendants’ Motion”).

On September 6, 2017, Uniloc served its Final Election of Asserted Claims against Big Fish consisting of U.S. Patent No. 7,069,293 (“’293 patent”) claims 1, 12, and 17, U.S. Patent No. 6,510,466 (“’466 patent”) claims 15, 16, 17, 22, and 30, and U.S. Patent No. 6,324,578 (“’578 patent”) claims 1, 8, 17, 27, and 38.

On September 8, 2017, Uniloc served its Final Election of Asserted Claims against ADP consisting of ’293 patent claims 1, 12, and 17, ’466 patent claims 15, 16, 17, and 35, ’578 patent claims 1, 8, 17, and 38, and U.S. Patent No. 6,728,766 claims 7, 8, 11, 13, and 17.

Therefore, Uniloc and the Defendants jointly move to withdraw Defendants’ Motion as moot based upon Uniloc having made its Final Election of Asserted Claims pursuant to General Order 13-20.
