ORDER

Before the Court is the Unopposed Motion for Extension of Time for Plaintiffs Advanced Micro Devices, Inc. and ATI Technologies ULC to Comply with P.R. 3-1 & 3-2 (Infringement Contentions) and for Defendant Realtek Semiconductor Corp. to Comply with P.R. 3-3 & 3-4 (Invalidity Contentions) and Standing Order Regarding Subject-Matter Eligibility Contentions. (Dkt. No. 32.) In the Motion, the parties request an extension of time to serve P.R. 3-1 & 3-2 Infringement Contentions from July 15, 2022 up to and including July 26, 2022 and an extension



of time to serve P.R. 3-3 & 3-4 Invalidity Contentions and to comply with the Standing Order Regarding Subject-Matter Eligibility Contentions from September 9, 2022 up to and including September 20, 2022. (*Id.* at 2.) The Motion is unopposed. (*Id.*)

Having considered the Motion, and noting its unopposed nature, the Court finds that it should be and hereby is **GRANTED**. Accordingly, the Court **ORDERS** that the deadline for Plaintiffs to serve their P.R. 3-1 & 3-2 Infringement Contentions is **extended** up to and including July 26, 2022 and the deadline for Defendant to serve its P.R. 3-3 & 3-4 Invalidity Contentions and to comply with the Standing Order Regarding Subject-Matter Eligibility Contentions is **extended** up to and including September 20, 2022.
