**TOUCHSTREAM'S UNOPPOSED MOTION FOR LEAVE TO FILE EXHIBITS THAT
EXCEED PAGE LIMITS RELATED TO TOUCHSTREAM'S MOTION TO COMPEL
ADDITIONAL DISCOVERY ON COMCAST'S SUPPLEMENTAL DISCLOSURES**

Plaintiffs Touchstream Technologies Inc. ("Touchstream,") moves for leave to exceed the 5-page limit for attachments to discovery motions established by the Court's Discovery Order. *Touchstream Technologies, Inc. v. Altice USA Inc. et al.*, 2:23-cv-00060-JRG, Dkt. 72, ¶ 9(b) (former consolidated docket). Touchstream requests that the Court waive the five (5) page limit for the four (4) exhibits Touchstream anticipates attaching to its Motion to Compel Additional Discovery on Comcast's Supplemental Disclosures. Good cause for this extension exists because multiple exhibits

are needed to provide the full history of the dispute and provide the Court with the interrogatories and deposition testimony at issue. The parties have conferred and agree a 15-page limit is appropriate for this motion and response thereto.
