- **16.** The State would further show the said Defendant did then and there violate terms and conditions of Community Supervision by: Failing to pay Client Identification Card fee as directed by the Court and is \$0.00 in arrears as of 09/01/20.
- 17. The State would further show the said Defendant did then and there violate terms and conditions of Community Supervision by: Failing to pay Court Costs as directed by the Court and is \$25.00 in arrears as of 09/01/20.
- **18.** The State would further show the said Defendant did then and there violate terms and conditions of Community Supervision by: Failing to pay Crime Stoppers of Houston fee as directed by the Court and is \$50.00 in arrears as of 09/01/20.
