U.S. Patent No. 9,497,321 – Claim 20

[PRE] A non-transitory computer-readable medium comprising executable data capable of causing a program to perform the steps of:

[A] in response to an incoming call, detecting an identification of the incoming call from a calling party;

[B] assigning priority on the incoming call based on a predefined scheme, wherein a higher priority call is forwarded to a user and a lower priority call is forwarded to voice mail without notifying a receipt of the incoming call to the user of a time of receipt of the incoming call during a selective forwarding mode; and

[C] providing a notification for indicating a reception of the voice mail.

Claim 20

Application of U.S. Patent No. 9,497,321 to LGE

[PRE] A non-transitory computer-readable medium comprising executable data capable of causing a programmable device to perform the steps of:

LGE makes, uses, offers to sell, sells, and/or imports into the United States smartphones with Do Not Disturb (the “Accused Products”). The Accused Products include memory comprising executable code (i.e., a non-transitory computer-readable medium comprising executable code capable of causing a programmable device to perform steps) that causes the device to perform the steps of claim 20.

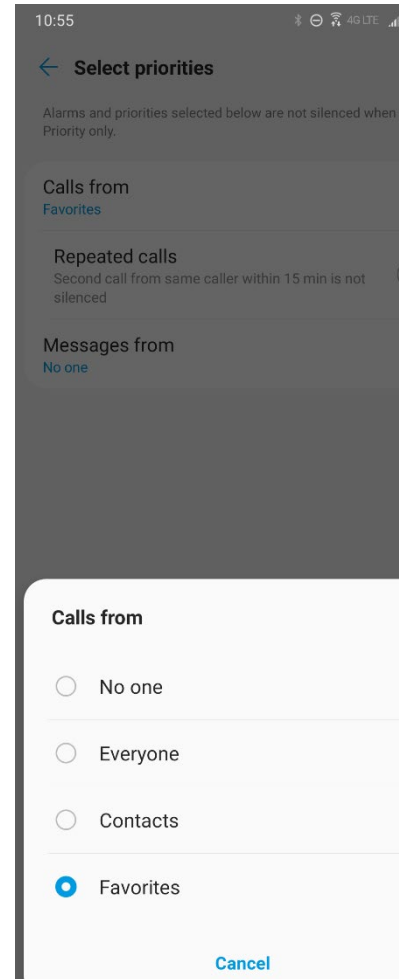
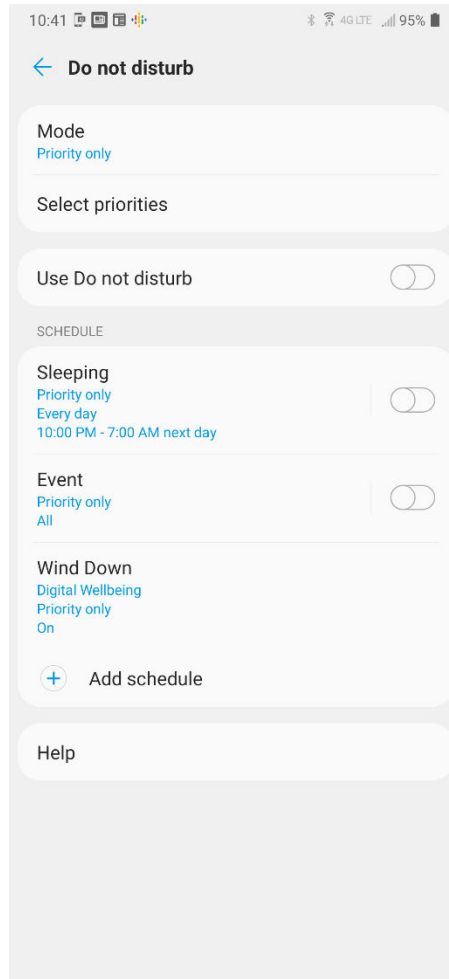

[A] in response to an incoming call, detecting an identification of the incoming call from a calling party;
