



<p>[pre] A method for sharing content, comprising:</p>	<p>To the extent the preamble is limiting, Lime operates a scooter sharing service Lime that allows users to unlock and ride Lime’s fleet of e-scooters and powered bikes via smartphone app. The scooters collect various information such as location and battery information/operational range. The data collected by the e-scooter is uploaded to a cloud computing server and then shared with a user or rider through a mobile application.</p> 
<p>a server, configured to communicate to a first and second client;</p>	<p>Lime’s mobile application necessarily requires a server communicating data between the scooter (first client) and the mobile device of the rider (second client).</p>
<p>receiving, at a server, from a first client, a shared content, and a unique identifier generated by a computer application running on the first client or server, for the shared content;</p>	<p>Lime’s server receives from a scooter shared content such as data collected by the on-board electronics of the scooter including GPS data, battery information, trip start and end times. As shown below, some scooters are marked as “GPS Tracked” indicating the availability of shared GPS data.</p> <p>The collected data is received by the server with a unique identifier that is associated with the scooter.</p>

<p>receiving, at the second client, the unique identifier, from the first client;</p>	<p>When a rider requests to ride a Lime scooter, the rider scans the unique identifier located on the scooter using the Lime mobile app.</p> <div data-bbox="589 688 1313 1253" data-label="Image"> </div> <div data-bbox="609 1291 1284 1627" data-label="Text"> <p>How do I unlock a Lime? <span style="float: right;">^</span></p> <p>To unlock a Lime-S electric scooter, Lime-E electric assist bike or LimeBike classic pedal bike, simply open the Lime app and tap on the "Ride" button at the bottom of the screen.
