Intervenor AgLogic submits this letter under Rule 28(j) of the Federal Rules of Appellate Procedure to notify the Court that on April 21, 2021, the Florida Department of Agriculture and Consumer Services denied AgLogic's application for state registration for new uses of aldicarb for oranges and grapefruit in Florida. Ex. A. While AgLogic intends to challenge that decision, the denial further confirms AgLogic's representation to this Court that there is simply no likelihood of Petitioners' claimed harm for at least six months. AgLogic Opp'n Br. at 14. It was, and is now even more, a certainty that aldicarb will not be permitted to be used on

oranges and grapefruit in Florida before April 30, 2021. The earliest date by which such application will be permitted is November 15, 2021. As AgLogic has argued, Petitioners' request for a stay is premature at best. *Id.* at 15.
