JOINT STATUS REPORT (2:22-cv-01298-JNW)

### **BACKGROUND**

This is an action for patent infringement, in which Plaintiff SurfCast Inc. asserts U.S. Patent Nos. 9,032,317; 9,043,712; 9,363,338; and 9,946,434 (collectively, the "Patents-in-Suit") against Defendant Microsoft Corporation. SurfCast brought this suit in the U.S. District Court for the Western District of Texas, but it was transferred to this District in September 2022. (Dkt. No. 58.) On October 12, 2022, the Court stayed this case pending final resolution, including any appeals, of *inter partes* review ("IPR") proceedings on the Patents-in-Suit and requested that the parties file a status report every six months updating the Court as to the status of the IPRs. (Dkt. No. 67 at 4.) Pursuant to that Order, the parties submit this report.

#### **IPR PROCEEDINGS**

IPRs on all claims of all Patents-in-Suit were instituted on October 7, 2022. *See* Paper 9 in each of IPR2022-00423, IPR2022-00590, IPR2022-00591, and IPR2022-00592. On October 2, 2023, Patent Trial and Appeal Board issued final written decisions in all four IPRs finding all challenged claims unpatentable. *See* Paper 21 in IPR2022-00591 and IPR2022-00592, and Paper 22 in IPR2022-00423 and IPR2022-00590.

The deadline for SurfCast to file a notice appeal from any of these final written decisions is December 4, 2023. *See* 37 C.F.R. 90.3.
