This letter responds to the applicant's communication filed on March 27, 2004.

Registration was refused under Trademark Act Section 2(e)(1), 15 U.S.C. §1052(e)(1), because the subject matter for which registration is sought is merely descriptive of the identified goods/services.

The examining attorney has considered the applicant's arguments carefully but has found them unpersuasive. For the reasons below, the refusal under Section 2(e)(1) is maintained and made FINAL.

Applicant's mark is TABBY'S SCRATCH PAD for intended use on a cat scratching pad.

Applicant asserts that the examining attorney has improperly dissected the mark. Although the applicant is correct in stating that a composite mark is tested for its validity and distinctiveness by looking at it as a whole rather than dissecting it into component parts, the examiner notes the following observation made by the Trademark Trial and Appeal Board:

It is perfectly acceptable to separate a compound mark and discuss the implications of each part thereof with respect to the question of descriptiveness provided that the ultimate determination is made on the basis of the mark in its entirety. An Examining Attorney's discussion of each word separately in order to show that the term in its entirety is descriptive is not the same thing as dissecting a mark. *In re Hester Industries, Inc.*, 230 USPQ 797, n.5 (TTAB 1986).

Here, applicant argues that the phrase "scratch pad" is suggestive. The Lexis/Nexis® materials reproduced a the end of this office action, clearly establish that a "scratch pad" is an item for use by a cat and also establish that "tabbys" are a type of cat. Judging the mark in relation to the goods its descriptiveness is clear. The goods are a pad that tabbies/tabby's scratch. Accordingly, the refusal under Section 2(e)(1) is maintained and made FINAL.

If applicant fails to respond to this final action within six months of the mailing date, the application will be abandoned. 15 U.S.C. §1062(b); 37 C.F.R. §2.65(a). Applicant may respond to this final action by:

- (1) submitting a response that fully satisfies all outstanding requirements, if feasible (37 C.F.R. §2.64(a)); and/or
- (2) filing an appeal to the Trademark Trial and Appeal Board, with an appeal fee of \$100 per class (37 C.F.R. §\$2.6(a)(18) and 2.64(a); TMEP §\$715.01 and 1501 *et seq.*; TBMP Chapter 1200).

In certain circumstances, a petition to the Director may be filed to review a final action that is limited to procedural issues, pursuant to 37 C.F.R. §2.63(b)(2). 37 C.F.R. §2.64(a). *See* 37 C.F.R. §2.146(b), TMEP §1704, and TBMP Chapter 1201.05 for an explanation of petitionable matter. The petition fee is \$100. 37 C.F.R. §2.6(a)(15).
