As you know, you and I have had several lengthy discussions relating to the registration of this mark. The following occurred relating to fully addressing the USPTO office actions of 12-22 and 12-23-2011:

- *1-17-12: I sent to you a preliminary proposed response to both prior OA's prep'd by you.
