## Preliminary Response with Reservation of Rights

The USPTO suggests that it will refuse registration of Applicant's mark, ÉLAN FURNITURE, "because of a likelihood of confusion with registered mark ELAN. The Examining Attorney has



indicated that similarity of the marks, similarity of the goods and/or services, and similarity of trade

channels of the goods and /or services are grounds for the 2(d) refusal of the Applicant's mark.

The Cited Registration Has Not Been Renewed

The cited registered mark, ELAN was registered on October 21. 2003. Therefore, the cited

registered mark was due for renewal on October 21, 2013. A review of the US Patent & Trademark

Office reflects no filing of a Section 8 & 9 for the cited registration. Therefore, the cited registration

has lapsed. Taking into consideration that the ELAN mark has lapsed, Applicant respectfully argues

that 2(d) refusal must be withdrawn, or in the alternative, the Applicant's mark should be suspending

pending the final outcome of the cited registration.
