APPLICANT'S MARK IS NOT CONFUSINGLY SIMILAR BECAUSE THE COMMON ELEMENTS ARE HIGH DESCRIPTIVE

The USPTO suggests that it will refuse registration of Applicant's mark, SPANTEEZ FOOT THONG, because of the potential registration of the mark FOOT THONG MIRACLE SOCKS. To avoid the potential suspension resulting from application serial number 85822292, Applicant respectfully asserts that Applicant's mark raises no 2(d) issue with the prior pending application because (1) the shared common element is high descriptive, (2) Applicant has disclaimed the common element, and (3) the images found in Exhibit B support the position that the common element is descriptive.

CONCLUSION

Applicant has fully responded to the Office Action. For at least the above reasons, Applicant asserts that Applicant's mark, SPANTEEZ FOOT THONG, is sufficiently distinct from the prior pending mark, so as not to result in consumer confusion. Applicant respectfully submits in good faith that all potential 2(d) refusals, rejections, and/or objections have been overcome and that the applied for mark is in condition for publication.
