The assigned trademark examining attorney has reviewed the referenced application and has determined the following:

Search

The trademark examining attorney has searched the USPTO's database of registered and pending marks and has found no similar registered marks that would bar registration under Trademark Act Section 2(d). TMEP §704.02; *see* 15 U.S.C. §1052(d). However, a mark in a prior-filed pending application may present a bar to registration of applicant's mark.

Application Not Entitled to Register – Two Earlier-filed Pending Applications

The filing dates of pending U.S. Application Serial Nos. 88060436 and 88325949 precedes applicant's filing date. See attached referenced applications. If the marks in the referenced applications register, applicant's mark may be refused registration under Trademark Act Section 2(d) because of a likelihood of confusion between the marks. *See* 15 U.S.C. §1052(d); 37 C.F.R. §2.83; TMEP §§1208 *et seq.* Therefore, upon receipt of applicant's response to this Office action, action on this application may be suspended pending final disposition of the earlier-filed referenced applications.

In response to this Office action, applicant may present arguments in support of registration by addressing the issue of the potential conflict between applicant's mark and the mark in the referenced application. Applicant's election not to submit arguments at this time in no way limits applicant's right to address this issue later if a refusal under Section 2(d) issues.

Applicant should note the following ground for refusal.

Trademark Act Sections 1, 2, 3, and 45 – Informational - Widely-used Commonplace Expressions

Registration is refused because the applied-for mark is a slogan or term that does not function as a trademark or service mark to indicate the source of applicant's goods and/or services and to identify and distinguish them from others. Trademark Act Sections 1, 2, 3, and 45, 15 U.S.C. §§1051-1053, 1127. In this case, the applied-for mark is a commonplace term, message, or expression widely used by a variety of sources that merely conveys an ordinary, familiar, well-recognized concept or sentiment. *See In re Volvo Cars of N. Am., Inc.*, 46 USPQ2d 1455, 1460-61 (TTAB 1998) (holding DRIVE SAFELY not registrable for automobiles and automobile parts because the mark would be perceived merely as an "everyday, commonplace safety admonition"); *In re Remington Prods., Inc.*, 3 USPQ2d 1714, 1715-16 (TTAB 1987) (holding PROUDLY MADE IN USA not registrable for electric shavers because the mark would be perceived merely as a common message encouraging the purchase of domestic-made products); TMEP §1202.04(b).

Terms and expressions that merely convey an informational message are not registrable. *In re Eagle Crest, Inc.*, 96 USPQ2d 1227, 1229 (TTAB 2010). Determining whether the term or expression functions as a trademark or service mark depends on how it would be perceived by the relevant public. *In re Eagle Crest, Inc.*, 96 USPQ2d at 1229; *In re Aerospace Optics, Inc.*, 78 USPQ2d 1861, 1862 (TTAB 2006); TMEP §1202.04. "The more commonly a [term or expression] is used, the less likely that the public will use it to identify only one source and the less likely that it will be recognized by purchasers as a trademark [or service mark]." *In re Hulting*, 107 USPQ2d 1175, 1177 (TTAB 2013) (quoting *In re Eagle Crest, Inc.*, 96 USPQ2d at 1229); TMEP §1202.04(b).

The attached evidence from Redbubble®, Etsy®, Teepublic®, Society6®, Refinery 29®, People®, USA Today®, Urban Dictionary®, and Dictionary.com®, shows that this term or expression is commonly used in the drag community and by celebrities as an alternate way of saying "OK" or "something that is said to affirm when someone is being put in their place". Because consumers are accustomed to seeing this term or expression commonly used in everyday speech by many different sources, they would not perceive it as a mark identifying the source of applicant's goods and/or services but rather as only conveying an informational message.

An applicant may not overcome this refusal by amending the application to seek registration on the Supplemental Register or asserting a claim of acquired distinctiveness under Section 2(f). TMEP §1202.04(d); *see In re Eagle Crest, Inc.*, 96 USPQ2d at 1229. Nor will submitting a substitute specimen overcome this refusal. *See* TMEP §1202.04(d).

Although applicant's mark has been refused registration, applicant may respond to the refusal(s) by submitting evidence and arguments in support of registration.

If applicant responds to the refusal(s), applicant must also respond to the requirement(s) set forth below.

Application Informalities

Identification of Goods

A portion of the identification of goods is unacceptable as indefinite because the goods listed were not specific enough and may be classified in several different International Classes. *See* 37 C.F.R. §2.32(a)(6); TMEP §1402.01.

The wording “headgear, namely, caps” in the identification of goods for International Class 25 must be clarified because it is too broad and could include goods in other international classes. *See* 37 C.F.R. §2.32(a)(6); TMEP §§1402.01, 1402.03. In particular, this wording could encompass “headgear, namely, hard hats” in International Class 9.

Applicant may adopt the following identification, if accurate:

Class 9: “Headgear, namely, hard hats”;

Class 25: “Clothing, namely, T-shirts, sweatshirts, hooded sweatshirts, pants, shorts, jackets, footwear, **headwear**, namely, hats and caps, blouses, bodysuits, dresses, jumpsuits, leggings, shirts, sweaters, undergarments”.

For assistance with identifying and classifying goods and/or services in trademark applications, please see the online searchable *Manual of Acceptable Identifications of Goods and Services* at <http://tess2.uspto.gov/netathtml/tidm.html>.

Please note that, while the identification of services may be amended to clarify or limit the services, adding to the services or broadening the scope of the services is not permitted. 37 C.F.R. §2.71(a); TMEP §1402.06. Therefore, applicant may not amend the identification to include services that are not within the scope of the services set forth in the present identification.

Multiple-class Application

The application identifies goods and/or services in more than one international class; therefore, applicant must satisfy all the requirements below for each international class based on Trademark Act Section 1(b):

- (1) **List the goods and/or services by their international class number** in consecutive numerical order, starting with the lowest numbered class.
- (2) **Submit a filing fee for each international class** not covered by the fee(s) already paid (view the [USPTO’s current fee schedule](#)). The application identifies goods and/or services that are classified in at least two classes; however, applicant submitted a fee(s) sufficient for only one class(es). Applicant must either submit the filing fees for the classes not covered by the submitted fees or restrict the application to the number of classes covered by the fees already paid.

See 15 U.S.C. §§1051(b), 1112, 1126(e); 37 C.F.R. §§2.32(a)(6)-(7), 2.34(a)(2)-(3), 2.86(a); TMEP §§1403.01, 1403.02(c).

Entity Indefinite

Applicant included the designation “Inc.” in its name; however, the legal entity is set forth as a limited liability company. In the United States, designations such as “Inc.” or “Corp.” are typically used by juristic entities incorporated under the laws of a specific state or federal statute. *See* TMEP §803.03(c). Applicant must clarify the inconsistency between the designation in applicant’s name and the identified entity type. *See* 37 C.F.R. §§2.32(a)(2), (a)(3)(i)-(ii), 2.61(b); TMEP §§803.02(c), 803.03(a), (c).

If applicant is a corporation, applicant must provide the legal name of the corporation and U.S. state or foreign country of incorporation or organization. *See* TMEP §803.03(c). If applicant is a limited liability company, applicant must amend the legal entity and provide the U.S. state under whose laws it is organized. TMEP §803.03(h).

If, in response to the above request, applicant provides information indicating that it is not the owner of the mark, registration will be refused because the application was void as filed. *See* 37 C.F.R. §2.71(d); TMEP §§803.06, 1201.02(b). An application must be filed by the party who owns or is entitled to use the mark as of the application filing date. *See* 37 C.F.R. §2.71(d); TMEP §1201.02(b).

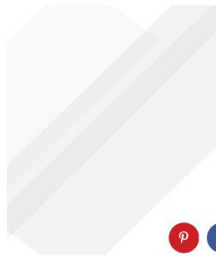
Who Actually Came Up With "Okurr," Cardi B Or Khloé Kardashian?

In case you've missed it, "okay" has recently received a long overdue makeover. The simple word has been transformed from a basic staccato confirmation into a sparkling vibration that rolls playfully around the tongue, a trilling affirmation that's as contagious as it is hard to say: "Okurr!"

Okurr — alternately spelled with up to four r's and sometimes with a t for emphasis at the end — first reached mainstream audiences [thanks to Khloé Kardashian on Keeping Up With The Kardashians](#).



Kardashians. Soon, the rest of her family, including matriarch Kris Jenner, were using the word as an alternate way to say "Okay, girl, I see you!" But the word has reached peak popularity since last fall thanks to rapper Cardi B, who's also a fan of punctuating her statements with that okay paired with a rolling r.

Fresh off the release of her new album *Invasion of Privacy* and her pregnancy reveal on [Saturday Night Live](#), Cardi co-hosted *The Tonight Show Starring Jimmy Fallon* on April 10. [The rapper explained](#) her favorite catchphrases to Jimmy Fallon, and after running through several others she uses frequently — like "aeeeeou" — she explained the proper uses of *okurr*: "It depends on the situation that you're in. If somebody checks somebody, it's like...okurr! I didn't know she had all of that in her, *okurr*! It's like *okaaaay*, but okay is played out. We've done that already!"

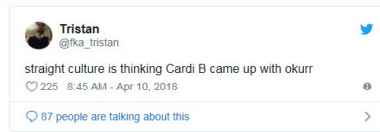


(By the way, if you're self-conscious about achieving the proper pronunciation, Cardi describes it as a noise made by a "cold pigeon in New York City.")

Some Kardashian fans have been confused about why Cardi has yet to credit Kardashian for coining [her new favorite term](#). But it turns out Koko just *popularized* the phrase, but didn't make it up. *Okurr*, in fact, actually derives from the [same place where many catchphrases come from](#): Drag culture. *RuPaul's Drag Race* contestant Laganja Estranja [most often gets the credit](#) for first using the word on the show, though other personalities like Willam, Alaska Thunderfuck, and Alyssa Edwards are all fans of *okurr*, too.

The colloquialism has even received an entry on Urban Dictionary, with the explanation that it "Originated from drag culture and [was] popularized by *RuPaul's Drag Race*, and then by *Keeping Up With the Kardashians*." So while we can indeed credit Kardashian for first bringing her favorite phrase to the mainstream, drag slang deserves the *true* credit — yet another reminder that many things that are deemed "cool" in popular culture often have roots in marginalized communities.

But the gag is (yup, yet another phrase that [originated in drag culture](#)) that the *okurr* timeline doesn't even begin with drag slang. As [this Reddit thread points out](#), the *actual* origin of *okurr* as we know it is a bit problematic. Back in 2010, Broadway actress [Laura Bell Bundy](#) (you might recognize her as the original Amber from *Hairspray* on Broadway) created a comedy web series with various fictional characters, including Shocantelle Brown, a hair stylist who appeared in a [weave advertisement skit](#). "My name is Shocantelle Brown, and I sho' can tell you need to come to I be-weave, because you need to take care of yo' hair, *okurr!*?"

Now, in the sketch, Bundy is not technically wearing blackface, but her nose is enlarged and she's both appropriating *and* making fun of Black salon culture...so, as previously stated, the video is problematic as hell, even if it was intended to be funny. Still, it seems that [the clip](#) of Bundy-as-Shocantelle turning "okay" into "okurr" is the first video evidence we have of *okurr* appearing in the modern vernacular, a funny word that was likely picked up and reused in jest and now, eight years later, is a part of our pop-culture vocabulary.

This investigation is not closed yet, however. Just like many other "trends" that make their way from small communities to the mainstream, it's impossible to *truly* nail down the origin of this vibrato twist on okay. It's very likely that someone else first uttered "okurr" long before Bundy did it as Shocantelle. So if you have any information about the *true* beginnings of *okurr*, please let us know. But for now, we can definitively say that neither Cardi nor Koko can take credit. Though we *can* thank them for putting on those of us who weren't familiar. Okurr!?! (Sorry, couldn't resist.)

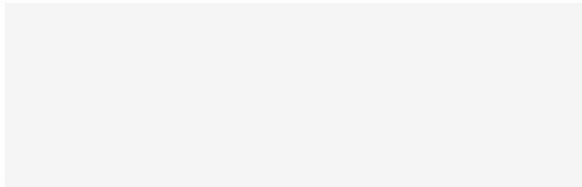

Rapper Cardi B popularized *okurrr*, a way of saying OK with surprise or sass—and properly delivered with a high-pitched trill. As Cardi B described on *The Tonight Show with Jimmy Fallon* in April 2018 after the release of her album *Invasion of Privacy*, *okurrr* should sound like “a cold pigeon in New York City.”

While Cardi B made *okurrr* a signature phrase of hers, it appears to originate in drag culture, as notably featured in *RuPaul’s Drag Race* by the contestant Laganja Estranja. RuPaul has credited *okurrr* to Broadway actor Laura Bell Bundy.



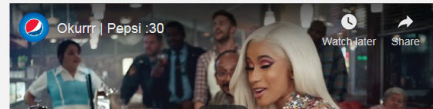
